Free Meal Services Extended Through May 15

HCPSS will continue to provide free Grab-N-Go meals to anyone age 18 and under and/or any HCPSS student, regardless of age, throughout state-mandated school closures, extended through May 15.

Participants will be given a Grab-N-Go snack, lunch and dinner for that day, as well as a Grab-N-Go breakfast for the following day. Friday distributions at school-based locations only also will include meals to sustain children through the weekend. Participants are encouraged to bring a bag to carry home meals each day.

Children do not need to be present; parents/guardians may pick up meals for their child(ren). There is no application, enrollment, or fees to participate in this program.

Devices for Student Learning

Most of the more than 13,000 student technology devices that have been requested have been delivered to students through device distribution locations or by FedEx delivery.

Unfortunately, due to unprecedented volume at FedEx, there still are some devices that have

not yet reached their destination. We expect devices that were requested before April 10 and have not yet been received to be delivered by the end of the day Tuesday, April 21. Devices that were requested after April 10 will be packaged and shipped as soon as possible. Teachers are aware that not all students may have immediate access to a device and will accommodate those students as necessary.

Families who did not initially request to borrow a device, or indicated they did not need one but now see the need for one, can request a device via HCPSS Connect. Directions on requesting a device can be found on the [HCPSS website](#).

TECH TIDBITS

Important:Canvas Notifications

Canvas has preset notification settings to inform you when new information is posted in Canvas. However, the preset settings DO NOT include push notifications (ie. parents do not get emails when new posts are made on Canvas). In order to receive notification emails informing you of any new information, you will need to follow the directions below to change your settings.

1. Login to your Parent Canvas Account (do NOT log in to your child's hcpss.me account)
2. From the menu on the left, select "Account"
3. Choose "Notifications" from the dropdown menu
4. Turn on "Announcements" and any other preferences you choose
5. Be sure to check to make sure your correct email address is listed

You will now receive an email notification any time new information is posted in Canvas.

INFORMATION FROM PAST NEWSLETTERS

Please also take a moment to review what your child's schedule will look like once distance learning begins at <https://www.hcpss.org/health/coronavirus/col-schedules/> (scroll to the bottom to see elementary). It is important to note that as the children move into virtual learning, the teachers are checking in with the students weekly to see how they are doing, taking a temperature check, and allowing the students to ask questions. This is considered as "check-in" time for the students. During this time, the children are the teacher's focus. As students ask questions and gain information, we ask that parents do not interrupt or join the check-ins with or for the child. If you have any questions after the check-ins, you are always welcome to email your child's teacher directly. We want to ensure the children come first and their check-ins don't lead to quick conferences or questions from adults. We hope you understand our priority. Also, in the name of safety, teachers will only be admitting those children to check-in with a Howard County issued email address. Parents will not be able to use their personal email addresses to enter the check-ins or virtual meetings. To ensure this happens, students should be logging into hcpss.me to access Canvas and all other resources. If you have an emergency and should need to use another email address, you will need to make the teacher aware of the change before the meeting begins. We will be using the Google Meet platform and Canvas for distance learning. It is important that your child knows how to login to Canvas. 2020-2021 Kindergarten and New Family Registration (Not Current Students)

*Please make certain you are in the screen for 20-21 if registering for the next school year.
Please read this message in its entirety.*

Please see the updates below regarding the updated process for registration for Pre-K and kindergarten for the 2020-2021 school year. You will also find updated information regarding early admission to kindergarten and first grade.

Kindergarten Registration

Parents/guardians of new incoming students and those entering kindergarten in the 2020-

2021 school year (who are not already enrolled) are able to begin the enrollment process online, followed by completion of the registration process when schools reopen.

Once school buildings reopen, parents should be contacted to complete the registration at the child's school. Parents or legal guardians must visit their child's school and provide proof of parental relationship and any other documents not provided during the online registration process.

Early Admission to Kindergarten

Due to state-mandated school closures, early admission appointments scheduled during this time are canceled and will be rescheduled at a later date. Additionally, assessment dates and notification regarding acceptance or denial of application have been postponed until schools reopen, and will be shared at a later date.

Early Admission to First Grade

Parents/guardians applying for early admission to first grade may submit all required documentation electronically to their prospective school. After schools reopen, parents or guardians will be contacted by their prospective school regarding an assessment appointment.

Pre-K Applications (Manor Woods Does Not have a Pre-K Program)

Due to state-mandated school closures, Pre-K application and enrollment for the 2020-2021 school year has been postponed. Once schools reopen, applications may be completed and returned to schools.
